Recognition was accorded for classes VIII to X (E.M) for the academic year 2014-15, in respect of Alphores High School Sulthanabad, Sulthanabad, Sultanabad(v), Sultanabad(m), Peddapalli(dist).

The Correspondent of Alphores High School Sulthanabad, Sulthanabad, Sultanabad(v), Sultanabad(m), Peddapalli(dist) has submitted the proposals for grant of Renewal Recognition of classes VIII to X (E.M) (with three sections) from the year 2024-25 to 2033-34.

The Mandal Education Officer, Sultanabad, Peddapalli has verified the proposals with reference to the conditions laid down in the Recognition orders and GO Ms No 1/Edn, Dated: 01-01-1994 and subsequent Government Orders submitted a detailed report through the letter

After careful examination of the proposals of the Correspondent and report of the Mandal Education Officer, Sultanabad, Peddapalli based on the recommendation of the District Education Officer, Peddapalli, the Regional Joint Director of School Education, Warangal is pleased to accord the Renewal Recognition of Classes VIII to X (E.M) (with three sections) for a period of ten (10) years from 2024-25 to 2033-34 in respect of Alphores High School Sulthanabad, Sulthanabad, Sultanabad(v), Sultanabad(m), Peddapalli(dist). The management is requested to follow the conditions.

1. The above Renewal Recognition is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre requisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any pre requisites as stipulated, the Renewal Recognition now being given is liable to be withdrawn at any time.

2. That the society shall abide to the rules and regulations made in the Govt. Orders 1st cited and subsequent orders.

3. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern another facilities.
4. That the Renewal Recognition is accorded to the Alphores Educational Society.
5. The Renewal Recognition is accorded to run the school in the locality and there shall not be any change in the premises of locality specified in the orders.
6. The management should follow the G.O.Ms.No.22 ,dated 18-07-2017 i,e ., the weight of the school bag not to exceed 4kg for VI-VII,4.5 kg for VIII-IX and 5 kg for X.
7. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational Officer, latest by September
8. The Management has to follow the government norms from time to time, for collection of fee from students.
9. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the Educational activities and conducting authorized examinations without permission of DEO.
10. The management should follow the guidelines issued in G.O.Ms. No. 36., School Education (General) Dept., Dt:- 16-12-2017 for the safety and security of the children in the schools.
11. The management should pay the mandate taxes due to the concerned departments as per schedule fixed by the Government.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments
13. The school shall have 'first aid-kit' and the teachers shall be trained in first aid.
14. That any children studied in recognized school of other states/countries affiliated to the bodies recognized by the state or central government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
15. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
16. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
17. If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
18. The Correspondent should submit Renewal of Recognition proposals before 90 days of the expiry of Renewal Recognition.

19. The Educational Agency should Implement the Guidelines for Safe and Effective use of Internet & Digital Technologies in schools and school buses issued by CBSE vide Circular No.Acad-32/2017, dated 18.08.2017 communicated by MHRD, Govt. of India.

20. The Educational Agency should Implement the Model Education Code prepared by National University for Educational Planning and Administration in 2015

21. That educational agency shall not permit the students of any D.Ed/B.Ed colleges or college of physical education or any teacher training institution to have teaching practice without the permission of the District Educational Officer.

22. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.


23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

24. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children

25. The school shall constitute Committees for redressal of the Public/ Staff/ Parents/ Students grievances, Internal Complaints Committee on Sexual Harassment and Committees under POCSO (Protection of Children from Sexual Offence) Act, 2012 and details of these Committees along with contact details shall be displayed prominently on School Notice Board and conspicuously on the School Website for the information of all the stakeholders.

The Mandal Educational Officer, Sulthanabad has scrutinized the proposals submitted by the Correspondent, Alphores High School Poosala Road, Sulthanabad(M), Peddapalli District for grant of Renewal Recognition for classes Nursery to VII E/M for the year 2018-19 to 2027-28 as per the conditions 1st cited above and submitting his report in the 3rd & 4th cited and according to Online Registration for issuing recognition orders.

After carefully examination of the reference cited and the conditions prescribed in G.O. Ms. No. 1 Education Dt. 1-1-1994, The District Educational Officer, Peddapalli is hereby accorded Grant of Renewal Recognition for the classes Nursery to VII E/M for the year 2018-19 to 2027-28 in respect of Alphores High School E/M, Poosala Road, Sulthanabad(M), Peddapalli District subject to the following conditions.

1. That the society abides by the instructions/rules and regulations made by the Government of authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timing, Vocational and mid-term Holidays shall be followed pre-scribed by the Government from time to time.
5. As per the staffing pattern the qualified staff within the age limits prescribed by the Government for Government Employees shall be appointed.
6. Appointment of Teaching and Non-Teaching Staff within the age limits prescribed by the Government for Government Employees shall be appointed.
7. That the results of Institutions shall be satisfactory every year.
8. That the records/accounts shall be furnished to the District Educational Officer every year by 30th September at the latest.
9. That the governing body/Staff selection committee shall be furnished to the District Educational Officer every year.
10. The approval of the correspondent ship should be get approved by the competent authority.
11. That the pay structure/fee structure fixed by the governing body shall be get approved by the District Educational Officer every year.
12. That the school shall not be closed without giving prior notice both to the parents/District Educational Officer and to the competent authority concerned at least 6 months before.
13. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
14. That the society shall submit proposal for renewal of provisional recognition will in advance i.e. at least 6 months prior to the date of expiry of the renewal.
15. Next higher classes additional sections should not be opened with-out prior permission from the competent authority.
16. Sufficient Play grounds, Library Books, Laboratory equipment shall be provided as per rules.
17. Provide suggestion boxes in prominent place in the school premises.
18. Compulsorily provide the extinguishers and fire fighting equipments as prescribed in the National Building Code of India part IV fire protection 1997 and provide by fire service department of the state.
19. Maintain first Aid Kits in sufficient numbers in the school premises.
20. Follow the rules and regulations prescribed in Cir. Memo No. 21748/D1/97 Dt. 16-2-1998 and other orders of Transport Authority regarding parking of school Vehicles/maintenance of vehicles and ensure safety of children and shall obtain fitness of the school vehicles from the transport authorities as prescribed by the Government from time to time.
21. The cost of providing Zebra crossing at the roads crossing near the schools which are located in Municipal Corporation/Town shall be met by the school management.
22. Have adequate personnel to guide the movement of the children to ensure road safety and transportation.
23. The management should follow the text books and syllabus prescribed other than the syllabus text books, prescribed by the Government should be used.
24. The Hindi Subject should be taught for the students of VI Class and higher classes.
25. That all Condition prescribed in G.O.Ms.No. 1 Dt. 1-1-1994 & G.O.Ms.No. 41, Dt. 11-5-2006 and other orders issued by the Government time to time. Which are not specified in these proceedings shall be completed with.

The Correspondent is requested to submit compliance report on fulfillment of conditions prescribed, within three months through Inspecting officer concerned without fail. The receipt of the proceedings shall be acknowledged.
